<u>SECTION 1</u>: The Zoning Ordinance of the Town of Gaines, Orleans County, New York, be and the same is hereby amended as follows:

Article VI, Section 665 Farm Labor Housing Within Agricultural Districts

Delete existing subparagraph b) of Section 665 in its entirety and insert new subparagraph b) as follows:

"b) The maximum gross density of farm labor housing shall not exceed six (6) dwelling units, or (6) single wide trailers, or (3) double wide trailers per acre. The occupational density for each dwelling unit, single wide, or double wide mobile home shall be the greater of (i) the number of sleeping quarters containing at least 50 square feet of floor area for each occupant over the age of 2 years, or (ii) the square feet of floor area for each occupant over the age of 2 years purusant to applicable Federal, State, or local Health Department rules or regulations governing occupational density standards for Migrant Farmworker Housing."

SECTION 2: All other provisions of the Zoning Ordinances of the Town of Gaines, not otherwise amended or modified herein shall remain in full force and effect.

<u>SECTION 3</u>: This local law shall take effect immediately upon filing in the office of the Secretary of State of the State of New York.
