

TOWN OF GAINES

Regular Meeting - November 8, 2018

The regular meeting of the Town Board of the Town of Gaines, County of Orleans, State of New York was called to order by Supervisor Joseph Grube at 7:00 P. M. on the 8th day of November, 2018.

PUBLIC HEARING - 2019 TOWN BUDGET

Supervisor Grube opened the Public Hearing on the 2019 Town of Gaines Budget at 7:00 P. M. He reviewed the Tentative Budget as adopted on October 30, 2018. Explained the Equalization Rate as set by the State of New York; the difference between the 2019 rate at 98% versus 2018 rate at 100% and how it effects the tax rate. Councilperson Neilans questioned the use of fund balance, and it was explained how the fund balance should be maintained a certain levels, and excessive fund balances mean you are overtaxing the taxpayers.

The following changes to the Tentative Budget were made, as follows:

Water Dist. 9 Revenue 2140 Metered Water	\$4,700 reduced to \$4,400
Water Dist. 10 Revenue 1001 Real Prop. Taxes	\$9,000 increased to \$9,400
Water Dist. 10 Revenue 2140 Metered Water	\$14,211 reduced to \$13,811

The 2019 Town of Gaines budget lowers the tax levy, and lowers the tax rate for both Village of Albion residents and Gaines town-wide residents. Maintains services, as well as being below the State mandated "Tax Cap".

RESOLUTION NO. 108 - 1118
APPROVING PAYMENT ADJUSTMENT TO CONTRACT WITH THE TOWN OF ALBION FOR CODE
ENFORCEMENT SERVICES

Moved by Councilperson Neilans and seconded by Councilperson Allport to adjust the annual payment to the Town of Albion for Code Enforcement services to \$19,650 for 2018 and \$19,650 for 2019.

Discussion: Prior Board failed to update the agreement with the Town of Albion since 2016. When the Town of Gaines was billed for services, there was no authorization to pay the amount billed. This resolution corrects the problem.

Discussion: Prior Board failed to pay for professional services rendered in connection of the 2015 Town Audit.

RESOLUTION NO. 110 - 1118
DISCUSSION ON ZONING PROJECT STEERING COMMITTEE AND APPOINTMENTS THERETO

Moved by Councilperson Allport and seconded by Councilperson Neilans to appoint eleven (11) members to serve on the Zoning Review Steering Committee. The following will serve on this

committee: Brian Alexander, Ray Burke, Brenda Radzinski, Mike Grabowski, Jim Navarra, Toni Plummer, Justin Kirby, Al Capurso, Corey Black, Doug Syck and Bruce Kirby.

Attorney Heath said the Town Board may direct the Committee to appoint their own Chairperson and co-chairperson (at the first meeting); failure to appoint such chairpersons, the appointment will revert back to the Town Board to appoint. The meeting of this Committee should comply with NYS Open Meeting Laws.

Discussion: The Zoning Steering Committee is designed to bring a "fresh set of eyes" to the zoning process in the Town of Gaines. LaBella will lead the discussion and provide the assistance to move the project forward.

DISCUSSION ON ZONING MORATORIUM REQUESTS

LaBella has prepared the paperwork for a Solar Moratorium and a schedule for a Public Hearing. Councilperson Allport asked why have a moratorium, Attorney Heath responded that it allows the Town to review, make changes, etc. Bruce Kirby said all solar vendors prefer to know in advance what a Town is doing regarding Solar projects within the Town. Marilyn Miller submitted a letter and commented regarding the ZBA's recommendation. LaBella will do a presentation to the ZBA, then the ZBA can express their thoughts. Introduce a Local Law in January, with a Public Hearing in January or February.

Al Capurso requested a Moratorium on "any destruction of green space within the Cobblestone Historical District; as well as on any subdivision of property". Mr. Capurso said it would be prudent to issue a moratorium until LaBella concludes the new Zoning Ordinance. He feels it creates a short term gain and a long term blight. He wanted to make it clear that he is in favor of development in Gaines, just not in the Historical District.

PRIVILEGE OF THE FLOOR

Toni Plummer has attended recent ZBA meetings and said the meetings are not being conducted according to Open Meeting Laws, and cited various problems. C. W. Lattin attended a recent ZBA meeting, and his observation is that legal counsel should be present at their meetings.
