RESOLUTION NO. 123 – 1219

SEQRA NEGATIVE DECLARATION FOR THE REPEAL OF THE TOWN'S ZONING ORDINANCE AND ADOPTION OF THE GAINES ZONING REGULATIONS AND THE OFFICIAL ZONING MAP BY LOCAL LAW

WHEREAS, the Town Board of the Town of Gaines ("Town Board") proposes to enact a Local Law to adopt zoning regulations and repeal the existing Zoning Ordinance, including repeal of the existing zoning map and adoption of a new zoning map ("Action"); and,

WHEREAS, the Town Board considered the recommendations of the Zoning Advisory Committee and draft zoning text and map prepared by LaBella Associates and the Advisory Committee; and,

WHEREAS, the Town Board finds that the Proposed Action is Type 1 pursuant to the New York State Environmental Quality Review Act ("SEQRA"); and,

WHEREAS, the Town Board is the only Involved Agency; and,

WHEREAS, the Town Board has comprehensively reviewed Part 1 of the Environmental Assessment Form and environmental record concerning the Proposed Action, as well as completed the applicable Parts 2 and 3 of the Environmental Assessment Form;

NOW THEREFORE BE IT RESOLVED, that as indicated in the attached Negative Declaration of Environmental Significance, using the criteria for determining significance identified in 6 NYCRR Sect. 617.7(c) (1) and in accordance with 6 NYCRR Sect. 617.7(c) (2) and (3), no potential significant adverse environmental impacts were identified with this Action, and the Town Board hereby finds and concludes that the Proposed Action will not present a potential significant adverse environmental impact and hereby issues a Negative Declaration for the Proposed Action pursuant to SEQRA; and be it further

RESOLVED, that the Town Board's adoption of the Negative Declaration has been prepared in accordance with Article 8 of the Environmental Conservation Law of the State of New York and implemented under 6 N. Y.C. R.R. Part 617; and it is further

RESOLVED, that copies of this Resolution and notice of the Negative Declaration as adopted by the Town Board be filed, published and circulated to the extent required by any applicable ordinance, statute or regulation, including publication in NYSDEC's Environmental Notice Bulletin as well as provided to the Town Clerk.

RESOLUTION NO. 124 – 1219 ADOPTION OF LOCAL LAW NO. 2 OF 2019 – ZONING REGULATIONS FOR THE TOWN OF GAINES

WHEREAS, the Gaines Town Board has received a final draft of proposed Town of Gaines Zoning Local Law and Zoning Map that will replace the existing zoning ordinance and zoning map. The Zoning Local Law incorporates the following changes to the existing regulations: reestablishment of the Planning Board with responsibilities for special use permits and site plan review; revised list of permitted uses and definitions; design-based development standards for the Commercial-Historic zoning district;

regulations for new unmapped Residential and Planned Development zoning districts; revised criteria for certain permitted and special uses; new sign regulations. In addition, the zoning map is modified to expand the Commercial zoning district east along Route 104 to Brown Road, eliminate the Commercial zoning district at Eagle Harbor, and align zoning district boundaries with property lines where feasible, and

WHEREAS, appropriate public notice of the proposed zoning revisions were made, as well as referral to the Orleans County Planning Department for review and comment and notification to the Clerks of adjoining municipalities; and

WHEREAS, the Gaines Town Board has considered comments made by the public and interested agencies at the Public hearings held on October 3, 2019 and on December 9, 2019; and

WHEREAS, the Gaines Town Board, as the only involved agency, has completed the Environmental Review of the adoption of said Code revisions and issued a "Negative Declaration" of significance, pursuant to the State Environmental Quality Review (SEQR) regulations;

NOW THEREFORE BE IT RESOLVED that the Gaines Town Board hereby adopts the above described zoning revisions as a Local Law; and be it further

RESOLVED that the Town Clerk is directed to notify the Orleans County Planning Department of this action, to file the adopted law with the New York State Department of State, and to file appropriate notices and documentation as required by New York State law, and be it further

RESOLVED that this resolution shall take effect immediately, and that Local Law No. 2 of 2019 – Zoning Regulations will go into full force and effect upon receipt of notice of filing with the New York State Department of State.
