RESOLUTION NO. 79-1020

AUTHORIZING THE APPOINTMENT OF SECRETARY TO PLANNING BOARD AND ZONING BOARD OF APPEALS

Moved by Councilperson Neilans and seconded by Councilperson Rush to appoint Sarah Bradshaw as secretary to the Planning Board and Zoning Board of Appeals at the hourly rate set at the 2020 Organizational meeting (\$13.80 per hour).

PRESENTATION AND APPROVAL OF THE TENTATIVE BUDGET FOR 2021

The Town of Gaines Bookkeeper, Tim Hungerford, presented the Tentative 2021 Budget to the Board. He explained the easiest way to look at the budget is to look at the Total Property Tax Levy, compared to the previous three years, from 2018 of \$642,210 to the 2021 Proposed levy of \$624,357. He then examined Personnel costs, \$359,574 in 2018 down to \$322,399 for the 2021 Proposed Budget. He showed each budget category Equipment, Contractual, Benefits and Debt Service. Equipment had a spike in 2019, when the loader was purchased; Benefits sees an increase due to the Highway employees health insurance costs; Debt service has gone down as Debt is paid down or off (Highway Building), etc. He explained Contractual is where most money is spent annually; and remains approximately the same over the past few years. He then compared Budget vs. Actual, the use of Fund Balance, the recommended levels, and the status of the Fund Balances.

The Supervisor said he worked with the Town Clerk and Bookkeeper to present this budget that not only reduces the total tax levy, but maintains services, and holds the line on spending. This tentative budget reaches those goals. The total tax levy would be \$624,357.00, or .07% lower than the 2020 Adopted Budget.

RESOLUTION NO. 80 – 1020 ADOPTION OF THE 2021 TENTATIVE BUDGET

Moved by Councilperson Mannella and seconded by Councilperson Rush to approve and adopt the 2021 Tentative Budget as presented, with a Public Hearing set for Thursday, November 5, 2020 (as scheduled at the January 2020 meeting, in accordance with Town Law). The Clerk will publish the legal notice.

Discussion: The Supervisor discussed the purchase of the loader and why the borrowing is not needed at this point. The Highway Superintendent mentioned a new pick up truck may be needed in the near future; Tim Hungerford, Bookkeeper, said if the need arises, the Town should consider a borrowing as the rates are good now.
