Public Comments:

Ms. Smith asked about the increase for insurance. Ms. Albone explained that our Insurance Agent, Albion Agencies has advised the Town to expect a 15% increase in insurance for 2025. Ms. Smith also questioned the large jump of \$60,000.00 for the ambulance contract. Supervisor Allport indicated that since the tentative budget was prepared, the amount is now only expected to be \$35,000.00, not \$60,000.00. Ms. Smith asked how the employee benefits amount could decrease. Ms. Albone explained that one of the Highway employees is no longer receiving health insurance through the Town. Ms. Smith questioned why the snow removal line increased so much since we haven't had particularly bad winters for the past few years. Highway Superintendent Radzinski explained that the price of salt has increased and there is no way to predict how much snow we will get in any given year, we need to have the salt, in case we have a bad winter. Ms. Smith wondered about the line in the Highway section of the budget for CHIPS, what is that? Highway Superintendent Radzinski explained that it is sate reimbursement for road work that the Town Highway does. Ms. Smith inquired why, on summary page 1, is there a big increase in metered water for all districts except for district #5, which has a decrease. Ms. Albone explained that the amounts budgeted were based on actual usage for the districts in 2024. Ms. Smith asked what the impact would be on taxes with the new assessments and with the Gaines Fire District being dissolved. Supervisor Allport indicated there may be a slight increase in taxes, but it would be below the 2% cap. Ms. Smith also asked why the Town needs a new truck. Highway Superintendent Radzinski explained that the truck that is being replaced is a 2004 truck and he has had difficulty getting parts for repairs, due to the age of the truck. It was also explained by Supervisor Allport, that Gaines is the only Town in the County that still has ARPA funds left. Those funds are being utilized to offset the purchase of the new truck. The Town has been very responsible with the use of these funds.
